Dear Landowners, Members and Managers:

Starting May 20, 2026, Grassland Water District will dewater multiple canal systems for the 2026 Maintenance Projects. There will be no water in these systems after dewatering starts.

The canals/ditches that will be affected are Helm Canal, 240 Ditch, Meyers Ditch, Agatha Canal, Geis Ditch, Redfern Ditch, Almaden Ditch, and Double D Ditch.

Work on these systems will include structural improvements and excavation to enhance the District's ability to move water more efficiently. 2026 Maintenance Projects are scheduled for completion by July 17, 2026.
