Dear GWD & GRCD Landowners:

It's that time of the year again! Enclosed you will find the 2026 Fall Water Schedule. The date on the schedule is the date that your club needs to be ready to receive its fall water, though the actual start date may vary by a day or two. The District's water supply this year is good and we anticipate no problems meeting all habitat demands throughout the season. **Please note, that we will not start water unless we get a confirmation phone call, to the canal tender, that the club is ready to begin flooding up.** If you need to make changes in your scheduling, contact your canal tender immediately so we can arrange to accommodate your club. Please note that clubs wanting to **delay** their delivery start date run the risk of not being completely full by opening day of waterfowl season. It is the District's responsibility to get the water to the clubs, but it is each club's responsibility to ensure that they have enough time to fill.

We ask that you have all your water control structures in good working condition at all times. As always, inspect all your levee banks and discharge structures to ensure that they are in good working order and will be watertight. Check the inside of the pipes to make sure that they have not rotted or have obstructions that may slow water flows. **Remember, this is the Landowner's responsibility.** One of the best water conservation tools that clubs can use is their District canal tender. Keeping your canal tender informed of your water needs and providing him ample time to make adjustments is the best way to ensure good water conservation. The canal tender for North Grassland is Mike Boffa, (209) 704-5187 and the canal tender for South Grassland is Josh Landrum, (209) 704-5184.
